- (ii) Number of Programmes attended by the Independent Directors during the financial year ended 31st March, 2019 were 4 and Number of hours spent by the Independent Directors in such Programmes during the financial year ended 31st March, 2019 is 6 hours.

The number of programmes attended by Independent Directors on a cumulative basis upto 2019, were 12 and hours spent on cumulative basis is 18 hours.
